

Plascon “Win a R1000 every hour and Grand Prize of a Ford Ranger” Competition – Terms & Conditions

- By entering this competition, all participants agree to these terms and conditions.
- This competition is open to residents of South Africa only, except employees of Kansai Plascon, its advertising and promotions agencies and their immediate families.
- The competition runs from 08:00 on Friday 06 October and ends at 24:00 on Sunday 31 December 2017. Entries will not be accepted after this period.
- To participate in this competition, purchase any Plascon product and have the barcode of that particular product available for entry.
- Only Plascon products with a valid barcode number will be considered for entry.
- To enter, dial into the USSD string, *120*86716# and follow the prompts.
- Each entry will require the entrant to input the barcode of the Plascon Product purchased.
- Entry costs 20c for 20 seconds as per USSD entry. Networks automatically end each session after 120 seconds.
- All entrants are to retain and/or provide proof of purchase of Plascon products.
- One entry per Plascon product purchased can be entered into the competition.
- All winners in this competition are determined by random draw.
- The prizes to be won are:
 - o R1,000 cash prizes x 9 draws per day for 87 days i.e. 783 individual cash prizes of R1,000 each
 - o One Grand Prize of a Ford Ranger Wildtrak valued at R550 000
- A cash prize winner can only win once in a month over the 3 month promotional period.
- For cash prizes, an automated random draw will take place every hour from 08:00 am to 5:00 pm which amounts to 9 hourly draws per day. All entries received will go into the draw pool for the hourly cash prize for the remaining duration of the promotional period. Entries received after 5:00 pm will automatically go into the 08:00 am draw pool from the following day. The final cash prize draw will take place on 31 December 2017 at 5:00 pm.
- During the competition period, 5 entries will be randomly drawn every hour on the hour via an automated system. Therefore, a total of 45 names will be drawn per day as possible cash prize winners. If the first name cannot be reached within 3 attempts, the next name drawn will be contacted for the hourly win that the winner was drawn for. Winners will be contacted the day after each cash prize draw has taken place.
- Once notified, all winners will have 24 hours to provide the proof of purchase in the form of a till slip or invoice as well as a valid South African ID or work permit in order to qualify for the cash prize.
- Should a drawn winner not provide proof of purchase, the cash prize will be forfeited and the next winner drawn for that particular hourly win will be contacted.
- Once the cash prize winner is validated, he/she will receive an SMS with instructions on how to access a PIN number via USSD to withdraw the cash prize from any FNB ATM.

- The PIN number will be sent to the winner via SMS. For security reasons, the PIN number will only be valid for 4 hours. Should the 4 hours expire, a new PIN number can be requested by the winner following the same USSD process used to obtain the original PIN number.
- Once at the FNB ATM, "e-wallet services" must be selected, followed by the winner's cell phone number, valid PIN number and the amount to be withdrawn up to a maximum of R1,000.
- Winners may withdraw the cash prize in smaller parts if desired, however bank fees in respect of R6 per R500 withdrawn up to a maximum of R18 in total fees will become applicable from the second withdrawal. In other words, if the full R1,000 is withdrawn, no fees apply. If 2 x R500 is withdrawn, the fee amounts to R6 and if 10 x R100 is withdrawn the fee is R18. Winners must be aware that cash might only be withdrawn in multiples of R100 and bank fees could impact on not being able to withdraw the full cash prize of R1000 should the winner make more than 1 withdrawal.
- All entries received during 06 October 2017 and 31 December 2017 are eligible for the Grand Prize draw provided the terms and conditions are met.
- A cash prize winner is also eligible to win the Grand Prize
- Entrants who have purchased Plascon Micatex automatically receive 3 x additional entries into the Grand Prize Draw.
- To determine the winner of the Grand Prize of the Ford Ranger Wildtrak, 10 entries will be randomly drawn via an automated system on 1 January 2018. Of the 10 entries, the first 3 entries drawn will be contacted by 12 January 2018 to notify them that they are 1 of 3 finalists to win the Grand Prize. Should any of the 3 entrants not be contactable within 48 hours, the next name drawn from the 10 entries will be contacted as 1 of the 3 finalists.
- Once notified, the 3 final entrants selected will be required to provide original proof of purchase either in the form of a till slip or invoice in order to qualify for the grand prize draw.
- The winner of the Ford Ranger Wildtrak must be over the age of 18 and in possession of a valid driver's license to qualify for the grand prize draw.
- Once the 3 final entries have been validated, a draw will be conducted at a selected location that will be witnessed by a Kansai Plascon representative, its Managing Agency as well as a 3rd party auditor. The judges' decision is final and no correspondence will be entered into.
